AN ORDINANCE OF THE BOARD OF SUPERVISORS OF FISHING CREEK TOWNSHIP, COLUMBIA COUNTY, PENNSYLVANIA, MODIFYING AND AMENDING ORDINANCE NO. 1 – 1974, TO THE EXTENT HEREIN SET FORTH AND RATIFYING ALL OTHER PROVISIONS OF ORDINANCE NO. 1 – 1974.

<u>SECTION 1</u> – Section 2 of the Ordinance No. 1 – 1974 as to the maturity dates of the installments is amended to read as follows:

(the balance of principal)	

<u>SECTION 2</u> – Section 3 of the Ordinance No. 1 – 1974 as to amounts the Township covenants to pay in each fiscal year is amended as to said fiscal years to read as follows:

<u>SECTION 3</u> – Section 4 of said Ordinance No. 1 – 1974, as to the form of the note and the schedule of installment payment therein is amended to read as follows:

Fiscal year 1975, the sum of \$4,900.00 Fiscal year 1976, the sum of \$5,320.00 Fiscal year 1977, the sum of \$5,600.00 Fiscal year 1978, the sum of \$5,880.00 Fiscal year 1979, the sum of \$6,300.00

<u>SECTION 4</u> – All other Sections of Ordinance No. 1 – 1974 are hereby ratified and affirmed.
